Pretrial supervision is a condition of release ordered by a

DEFINITIONS

judicial officer for a person who has been charged with an offense(s) while awaiting the final disposition of their case.

Supervising body: a pretrial services staff person or agency

Probation supervision is imposed by a judicial officer as a sentence, a condition of a suspended sentence, or in lieu of incarceration.

Supervising body: a court-based agency, a county or state agency, a private company, or the court itself

Post-release supervision is commonly referred to as "supervised release." This is a period of community supervision imposed by the court to be completed after release from a jail or prison sentence.

Parole is the release of a person, by an administrative entity from jail, prison, or other confinement after the person has served a portion of their sentence.

Supervising body: a state or county agency
